Season Ticket Holiday Terms and Conditions 2021/22

By clicking 'Confirm 2021/22 Season Ticket Holiday', you agree to take a Season Ticket Holiday for the 2021/22 Season in respect of some or all of your seat(s) and the following terms and conditions shall apply:

- 1. Once you have clicked 'Confirm 2021/22 Season Ticket Holiday', you will not be able to cancel your Season Ticket Holiday in respect of the seat(s) you have decided to relinquish for the 2021/22 Season and the Club shall have the right to immediately offer the relevant seat(s) for sale to other members.
- 2. For the 2021/22 Season, your season ticket(s) in respect of the seat(s) you have decided to relinquish for the 2021/22 Season will not be renewed and you shall cease to be a Gold, Platinum, WM or Single-Year Avenell Club Member (as applicable) with associated benefits in respect of the relevant seats. If you are a Three-Year Avenell Club Member, your membership in respect of the seat(s) you have decided to relinquish for the 2021/22 Season will be suspended during the 2021/22 Season.
- 3. If you are a Gold, Platinum, WM or Single-Year Avenell Club Member:
 - 3.1. the Club will offer you the opportunity to purchase one season ticket for the 2022/23 Season per seat that you have decided to relinquish for the 2021/22 Season, such offer to be on such terms as may be determined by the Club acting in its sole discretion. For the avoidance of doubt, you are not guaranteed the exact seats you have relinquished for the 2021/22 Season (or seats near those). The Club would expect to communicate the offer of season ticket(s) to you during the renewal period for the 2022/23 Season. We will use the latest contact details that you have supplied to the Club and therefore it is your responsibility to ensure that the Club has your up-to-date contact details, including e-mail address.
 - 3.2. If you decline the Club's offer of season ticket(s) for the 2022/23 Season pursuant to clause 3.1 above, you will be offered a place on the relevant Waiting/Deposit List for your applicable membership category, subject to the applicable terms and conditions of the relevant List. Your place on the relevant Waiting/Deposit List will be allocated on a chronological basis by reference to the date that you pay the applicable fee. If you decline an offer of a place on the relevant Waiting/Deposit List, then should you wish to be a Gold, Platinum, WM, or Avenell Club Member for following seasons you would need to re-apply to join the relevant membership scheme.
- 4. If you are a Three-Year Avenell Club Member, your membership in respect of the seat(s) you have decided to relinquish for the 2021/22 Season will resume from the start of the 2022/23 Season and the term of your membership will be extended by one Season, subject to the terms of your Avenell Club membership agreement.
