Ball Squad Trials Terms and Conditions

These terms and conditions set out the basis on which you can participate in the Arsenal Ball Squad Trials ("**Trials**").

By applying to participate the Trials, you accept these terms and conditions in full. If you do not accept these terms and conditions, you should not apply and you will not be eligible to participate. Application is via online form submission at: https://www.arsenal.com/juniorgunners/competitions/apply-202324-ball-squad-trials (the "Website").

- The opening date for applications is 11 May 2023 once live on the Website (UK time) ("Open Date"). The closing date for applications is 21 May 2023 at 23:59 (UK time) ("Closing Date"). Applications received after the Closing Date will not be accepted.
- 2. To apply for the Trials, you need to visit https://www.arsenal.com/juniorgunners/competitions/apply-202324-ball-squad-trials and fill in the registration form with all required information, including answering any questions, by no later than the Closing Date.
- 3. Applications are open to paid Junior Gunners Members who will be aged 12-16 years during the 2023/24 season.
- 4. Consent from a parent or guardian must be obtained prior to application and the parent or guardian must agree to these terms and conditions in full. Successful applicants may be required to supply a completed parental/legal guardian consent form in accordance with Arsenal's directions in order to take part in the Trials. Applicants must be accompanied by a parent/legal guardian to the Trials.
- 5. Employees of The Arsenal Football Club Limited (company number 109244) ("Arsenal") or members of their immediate families are not eligible to apply.
- 6. Application is by online form submission at the Website only. No purchase is required to apply but you will require email and internet access to complete and submit the application. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of applying for the Trials.
- 7. A minimum of one hundred (100) applicants will be invited to take part in the Trials which will take place at Emirates Stadium, Hornsey Rd, London N7 7AJ on Saturday 3 June 2023 at such time to be confirmed by Arsenal to the successful applicants in advance. If more than 100 applications are received, applicants will be selected by an Arsenal representative based on the information completed within their application.

- 8. Successful applicants will be contacted to invite them to the Trials using the contact details provided in the application within 72 hours of the closing date. The email will confirm the applicant has been successful and will inform applicants of the final date and time of the Trials. If an applicant cannot be contacted or does not respond within 5 days, an alternative applicant will be selected at random from the remaining eligible applications.
- 9. Parents or guardians of the successful applicants will be asked to sign and complete an imagery consent form so that imagery and video of the trialists can be captured on the day. Please consider this carefully before applying.
- 10. All participants at the Trials will be scored anonymously by a team of Arsenal staff.
- 11. Once Trials are completed, twenty (20) participants will be selected to be members of the Arsenal Ball Squad for the 2023/24 season.
- 12. By attending the Trials, the Junior Gunner confirms that they can attend every fixture held at Emirates Stadium in the 2023/24 season (including, for the avoidance of doubt, all men's, women's, under-23's and Youth Cup matches) (the "Fixtures") and that a parent/guardian can collect the Junior Gunner from Emirates Stadium after all Fixtures taking place at night.
- 13. Each of the final selected squad members will also receive a full Junior Gunner membership for one year (the "Reward"). This Reward is non-transferable and no cash alternative will be offered.
- 14. If applicable, it is the responsibility of the Junior Gunner to ensure they have a valid passport and obtain relevant visas and vaccinations required to attend the Trials and take part in the squad, if selected.
- 15. Arsenal will use applicants' personal details for the purposes of administering the Trials. More information about how Arsenal handles personal data is available at www.arsenal.com/privacy-policy.
- 16. Applications must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete applications, or for electronic applications or notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such applications will be deemed void.
- 17. Arsenal reserves the right to withdraw or amend the Trials or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.
- 18. Applications must be strictly in accordance with these Terms and Conditions. Any application not in strict accordance with these Terms and Conditions will be deemed to be invalid. Arsenal reserves the right to verify the eligibility of any

- applicant and to exclude any applications which it believes to be invalid or in breach of these Terms and Conditions.
- 19. Arsenal's decision is final in all matters relating to the Trials and no correspondence will be entered into.
- 20. Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
 - a. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Promotion and/or the Reward, resulting from any cause whatsoever; or
 - b. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
- 21. Please note that these Terms and Conditions are governed by English law. This means that your application into the Trials and any dispute or claim arising out of or in connection with it will be governed by English law. You and Arsenal both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.
- 22. If you attempt to compromise the integrity or proper operation of the Trials by cheating or committing fraud in any way, Arsenal reserves the right to render your application invalid, seek damages from you and ban you from participating in any of their future Trials.
