
## Win an Arsenal Baby Highbury Sleepsuit - Terms and Conditions These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the competition to win an official Arsenal Baby Highbury Sleepsuit ("Competition"). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize. COMPETITION PERIOD: The start date for entries is 1 June 2023 at the time the Competition goes live on the Website ("Start Date"). The closing date for entries is 4 June 2023 at 11:59pm (UK time) ("Closing Date"). Entries received after the Closing Date will not be entered into the Competition. 2.
