Junior Gunners Monthly Quiz - Terms and Conditions

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the Junior Gunners Monthly Quiz competition (the "Competition"). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize.

Entry is only via online form submission and answering of multiple-choice questions each month at: https://www.arsenal.com/juniorgunners/competitions/JG-quiz2324-ChampionsLeague (the "Website").

- 1. COMPETITION PERIOD: The start date for entries is 6 July 2023 at the time at which the Competition goes live on the Website (UK time) ("Start Date"). The closing date for entries is 31 May 2024 at 23:59 (UK time) ("Closing Date") (the "Competition Period"). Entries received after the Closing Date will not be entered into the Competition.
- 2. TO ENTER: There will be a monthly quiz for each month during the Competition Period ("Monthly Quiz"). There will therefore be 11 monthly quizzes. To enter the Competition in each month, you need to visit https://www.arsenal.com/juniorgunners/competitions/JG-quiz2324-ChampionsLeague and answer the multiple-choice questions for the relevant Monthly Quiz and fill out the relevant information on the entry form.

Entrants can complete each Monthly Quiz once during the Competition Period to gain points by answering multiple-choice questions. One (1) point will be awarded to entrants where a question is answered correctly. No points will be awarded for incorrectly answered questions. By completing just one Monthly Quiz, you will be entered into the Competition.

- 3. ELIGIBILITY: Entry is open to paid Junior Gunners members aged 0-16 years only. Only one (1) entry per Junior Gunner is allowed for each Monthly Quiz.
- 4. If entrants are under 18, consent from a parent or guardian must be obtained prior to entry and the parent or guardian must agree to these Terms and Conditions in full. Winners may be required to supply a completed parental/legal guardian consent form in accordance with Arsenal's directions in order to claim their prize.
- 5. Employees of The Arsenal Football Club Limited (company number 109244) ("Arsenal") or members of their immediate families are not eligible to enter the Competition.
- 6. No purchase is required to enter but you will require email and internet access to enter the Competition. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Competition.
- 7. PRIZE: One (1) winner shall receive one (1) Arsenal 2023/24 home shirt signed by a number of the Arsenal men's first team players (subject always to shirt availability and player availability) (the "Prize"). For the avoidance of doubt Arsenal shall have sole discretion in relation to player shirt signatures. The Prize is non-transferable and no cash alternative will be offered.
- 8. Where applicable to the Prize(s) or parts of the Prize(s), Arsenal's terms and conditions at https://www.arsenal.com/ticket-membership-terms and https://arsenaldirect.arsenal.com/termsAndConditions shall apply.

9. Arsenal reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash

alternative to the Prize (or any part of it) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. All costs and expenses not included within the Prize are the responsibility of the winner(s).

- 11. SELECTION OF WINNER: In relation to each Monthly Quiz, one (1) point will be awarded to entrants where a question is answered correctly. No points will be awarded for incorrectly answered questions. For example, if you answer two (2) questions correctly in a Monthly Quiz, you will receive two (2) points. If you answer ten (10) questions correctly in total from multiple Monthly Quizzes over the course of the Competition Period, you will finish with a final score of ten (10) points. The winner will be the Junior Gunner with the highest cumulative Monthly Quiz points score achieved over the Competition Period as accumulated across all Monthly Quizzes for which such Junior Gunner was eligible and entered. All entrants' quiz points scores will be calculated once the final Monthly Quiz of the 2023/24 season has been completed. In the event that there is a tie for the most points received, the winner will be selected at random from all the tied entrants.
- 12. The winner will be contacted using the contact details provided on entry within 7 days of the Closing Date. If the winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 14 days, an alternative winner will be selected at random from the remaining eligible and correct entries.
- 13. Unless otherwise notified by Arsenal, the Prize will be delivered to the winner within 30 days of confirmation of the winner's address for delivery of the Prize.
- 14. awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
