

## Design our Junior Gunners Christmas Card Competition

**These terms and conditions (“Terms and Conditions”) set out the basis on which you can participate in the Design our Junior Gunners Christmas Card Competition (“Competition”). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize. Entry is by email only.**

**COMPETITION PERIOD:** The start date for entries is 5 October 2023 (“**Start Date**”). The closing date for entries is 15 October 2023 at 23:59 (UK time) (“**Closing Date**”). Entries received after the Closing Date will not be entered into the Competition.

1. **TO ENTER:** To enter the Competition, you need to email [juniorgunners@arsenal.co.uk](mailto:juniorgunners@arsenal.co.uk) with a copy of your submission. You will need to *send us your drawing for the front cover of our Christmas card with your full name, membership number and email address* by no later than the Closing Date.
2. **ELIGIBILITY:** Entry is open to parents and guardians on behalf of paid Junior Gunners Members aged 0-16 only. Only one (1) entry per person is allowed.
3. Consent from a parent or guardian must be obtained prior to entry and the parent or guardian must agree to these Terms and Conditions in full. Winners may be required to supply a completed parental/legal guardian consent form in accordance with Arsenal’s directions in order to claim their prize.
4. Employees of The Arsenal Football Club Limited (company number 109244) (“**Arsenal**”) or members of their immediate families are not eligible to enter the Competition.
5. By entering, all entrants warrant and undertake that they are the legal and beneficial owner of all intellectual property rights in their entry (including all images and text submitted by the entrant as part of the entry process), that their entry is their own original work and does not infringe any third party rights.
6. All entrants warrant that their entry does not infringe English law.
7. By entering this Promotion, entrants agree that any entry they submit may be used by Arsenal and their selected sub-licensees for marketing and promotional purposes in perpetuity, throughout the world in any and all media whether now known or hereafter invented without further remuneration (“permitted purposes”).
8. For your entry to be valid, it must meet the following criteria:
  - a. You must submit your entry as a high resolution JPEG image or PDF file format in full colour;
  - b. Your submission must not include any photos;
  - c. Your submission must not include any individual’s full name or other personal data of any individual;
  - d. Your submission must not contain anything that is, in Arsenal’s opinion, defamatory, derogatory, discriminatory or otherwise offensive.

9. Entry is by email only. No purchase is required to enter but you will require email and internet access to enter the Competition. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Competition.
10. **PRIZE:** There is one winner. The winner's design will be featured on the front of the Arsenal Christmas card which will be sent to all Junior Gunners at Christmas 2023 (the "**Prize**"). The Prize is non-transferable and no cash alternative will be offered.
11. Arsenal reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. All costs and expenses not included within the Prize are the responsibility of the winner(s).
12. Third party terms and conditions apply to parts of the Prize where applicable.
13. **SELECTION OF WINNER:** The best Christmas card design submission will be selected to be the winner by the judging panel in accordance with the following criteria:
  - a. **Arsenal Theme:** how your design incorporates the Club, its branding and colours;
  - b. **Arsenal Values:** how your design incorporates the Club's values and what Arsenal means to you;
  - c. **Creativity:** how creative your design is;
  - d. **Christmas:** how your design incorporates the festivity of Christmas.

The winner will be picked in accordance with the above criteria, through a panel which will include an independent judge. All eligible and correct entries received between the Start Date and the Closing Date will be considered.

14. The winner will be contacted using the contact details provided on entry within 14 days of the Closing Date. If the winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 14 days, an alternative winner will be selected by the judging panel from the remaining eligible and correct entries.
15. Details of the winner's name and county will be available on request for one month after the Closing Date by writing to Arsenal (including providing a stamped self-addressed envelope and stating the name and closing date of the Competition) at the address set out below. Full names of the judges will be made available on request.
16. Arsenal will use entrants' personal details for the purposes of administering the Competition and awarding the Prize. More information about how Arsenal handles personal data is available at [www.arsenal.com/privacy-policy](http://www.arsenal.com/privacy-policy).
17. **OTHER IMPORTANT INFORMATION:** Entries must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete entries, or for electronic entries or

winning notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such entries will be deemed void.

18. Arsenal reserves the right to withdraw or amend the Competition or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.
19. Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
20. Arsenal's decision is final in all matters relating to the Competition (including the Prize) and no correspondence will be entered into.
21. Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
  - i. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Competition and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or
  - ii. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
22. Arsenal reserves the right to disqualify any entrant posting an entry or a comment to Arsenal's social media platforms that is, in Arsenal's opinion, inappropriate, offensive or upsetting to other entrants, fans of Arsenal or directly aimed at Arsenal, or contrary to applicable law, and to remove any such entry or comment.
23. Arsenal reserves the right to pass on any images which cause it concern to the relevant authorities.
24. **GOVERNING LAW AND JURISDICTION:** Please note that these Terms and Conditions are governed by English law. This means that your entry into the Competition and any dispute or claim arising out of or in connection with it will be governed by English law. You and Arsenal both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.
25. **SPIRIT OF THE COMPETITION:** If you attempt to compromise the integrity or proper operation of the Competition by cheating or committing fraud in any way, Arsenal reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
