

## Junior Gunners 12 days of Christmas 2023 Terms and Conditions

These terms and conditions ("Terms and Conditions") set out the basis on which you can participate in the 12 days of Christmas competition (the "Competition"). By entering the Competition, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Competition and you will not be eligible to win the prize. Entry is via form submission on <https://www.arsenal.com/12days-christmas23> (the "Arsenal Website") or the official Arsenal app.

**COMPETITION PERIOD:** The start date for entries is 1 December 2023 ("Start Date"). The closing date for entries is 12 December 2023 at 23:59 (UK time) ("Closing Date") (the "Competition Period"). Entries received after the Closing Date will not be entered into the Competition.

**TO ENTER:** To enter the Competition, you will need to visit the Arsenal Website, which shall make available the full details of the Competition and a link to these Terms and Conditions. Correctly answer an Arsenal question and input your details (which shall include your full name, date of birth, email address and membership number) to the competition form provided (the "Form") and submit the Form. The Competition shall run each day throughout the Competition Period, with a prize draw taking place daily until the Closing Date. To enter any day's Competition you must submit the Form and enter the Competition for that day. The instructions for entry will be outlined on the Arsenal Website. All Competition entries for each day's prize draw must be submitted by 23:59 (UK time) on that day via the Arsenal Website, and no entry will be accepted after the Closing Date.

**ELIGIBILITY:** Entry is open to paid Arsenal Junior Gunners members only, aged 0 – 16. Only one entry per person is allowed per day of the Competition. Employees of The Arsenal Football Club Limited (company number 109244) ("Arsenal") or members of their immediate families are not eligible to enter the Competition.

Entry is via the Arsenal Website and the official Arsenal app only. No additional purchase is required to enter but you will require email and internet access to enter the Competition. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Competition.

**PRIZE:** There shall be a new prize draw available to enter every day of the Competition Period. The prize draw for each day is available for entry from 09:00 and closing at 23:59 for each respective day (UK Time). individually the “Prize” and collectively referred to as the “Prizes”.

The Prizes are limited to the Prizes themselves and do not include personal expenditure, transport costs and other incidental costs other than those specifically included. Third party terms and conditions apply to parts of the Prize where applicable.

**SELECTION OF WINNER:** The winner(s) will be picked at random from all eligible and correct entries received between the Start Date and the Closing Date.

The winner will be contacted using the contact details provided on entry within 14 days of the Closing Date. If the winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 14 days, an alternative winner will be selected at random from the remaining eligible and correct entries.

Unless otherwise notified by Arsenal, the Prizes will be delivered to the winner within 30 days of confirmation of the winner’s address for delivery of the Prizes.

**PUBLICITY AND PERSONAL DATA:** Details of the winners’ names and counties will be available on request for one month after the Closing Date by writing to Arsenal (including providing a stamped self-addressed envelope and stating the name and closing date of the Competition) at the address set out below. Arsenal will use entrants’ personal details for the purposes of administering the Competition and awarding the Prize. **OTHER IMPORTANT INFORMATION:** Entries must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete entries, or for electronic entries or winning notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such entries will be deemed void.

Arsenal reserves the right to withdraw or amend the Competition or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.

Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.

Arsenal’s decision is final in all matters relating to the Competition (including the Prizes) and no correspondence will be entered into.

Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise): any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Competition and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.

**GOVERNING LAW AND JURISDICTION:** Please note that these Terms and Conditions are governed by English law. This means that your entry into the Competition and any dispute or claim arising out of or in connection with it will be governed by English law. You and Arsenal both agree that the courts of England and Wales will have exclusive jurisdiction in connection with any such dispute or claim.

**SPIRIT OF THE COMPETITION:** If you attempt to compromise the integrity or proper operation of the Competition by cheating or committing fraud in any way, Arsenal reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
