

Prize Draw Terms and Conditions

Win an Arsenal Bruised Banana Set

These terms and conditions (“Terms and Conditions”) set out the basis on which you can participate in the prize draw to win an Arsenal Bruised Banana Set (the “Prize Draw”). By entering the Prize Draw, you accept these Terms and Conditions in full. If you do not accept these Terms and Conditions, you should not enter the Prize Draw and you will not be eligible to win the prize. Entry is only via online form submission at: <https://www.arsenal.com/juniorgunners/competitions/bruised-banana-set2324> (the “Website”).

1. **PRIZE DRAW PERIOD:** The start date for entries is 2 May 2024 at the time the Prize Draw goes live on the Website (the “Start Date”). The closing date for entries is 5 May 2024 at 23:59 (UK time) (“Closing Date”). Entries received after the Closing Date will not be entered into the Prize Draw.
2. **TO ENTER:** To enter the Prize Draw, you need to visit the Website and fill in the registration form with all required information by no later than the Closing Date.
3. **ELIGIBILITY:** Entry is open to parents and guardians (the “entrants”) on behalf of paid Junior Gunners Members aged 4 – 11 years only. Only one (1) entry per Junior Gunners Member is allowed.
4. Entrants under 18 must obtain consent from a parent or guardian prior to enter and the parent or guardian must agree to these Terms and Conditions in full. Winners may be required to supply a completed parental/legal guardian consent form in accordance with Arsenal’s directions in order to claim their prize. It is your responsibility to ensure that you can participate in the Prize Draw in compliance with local laws and regulations. Any entry submitted in breach of local laws and regulations shall be automatically null and void. Arsenal also reserves the right to determine that it cannot accept an entry or provide a prize due to local laws and regulations.
5. Employees of The Arsenal Football Club Limited (company number 109244) (“Arsenal”) or members of their immediate families are not eligible to enter the Prize Draw.
6. Entry is only via online form submission at the Website. No purchase is required to enter but you will require email and internet access to enter the Prize Draw. No refund may be claimed for any expenses incurred relating to the use of an email account or internet connection for the purpose of entering the Prize Draw.
7. **PRIZE:** Five (5) winners shall each receive one (1) Arsenal Bruised Banana set subject to availability (the “Prize”). The Prize is non-transferable and no cash alternative will be offered. The Prize does not include personal expenditure, transport costs and other incidental costs other than those specifically included. Where applicable to the Prize(s) or parts of the Prize(s), Arsenal’s Ticketing and Membership Terms and Conditions (www.arsenal.com/ticket-membership-terms) and/or the Arsenal Direct Terms and Condition of Sale (www.arsenaldirect.arsenal.com/termsandconditions) shall apply.
8. Arsenal reserves the right to substitute the Prize(s) (or any part of it/them) for a prize or prizes of equivalent or greater monetary value if this is necessary for reasons beyond its control. There is no cash alternative to the Prize (or any part of them) and unless agreed otherwise in writing the Prize is non-refundable and non-transferable. All costs and expenses not included within the Prize are the responsibility of the winner(s).
9. Third party terms and conditions apply to parts of the Prize where applicable.
10. **SELECTION OF WINNER:** Five (5) entrants will be picked at random from all eligible and correct entries received between the Start Date and the Closing Date (the “winners”).

11. The winner(s) will be contacted using the contact details provided on entry within 72 hours of the Closing Date. If a winner cannot be contacted or does not respond to confirm details for delivery of the Prize within 14 days, an alternative winner will be selected at random from the remaining eligible and correct entries.
12. Unless otherwise notified by Arsenal, the Prize will be delivered to the winner within 30 days of confirmation of the winner's address for delivery of the Prize.
13. **PUBLICITY AND PERSONAL DATA:** Details of each winner's name and county will be available on request for one month after the Closing Date by writing to Arsenal (including providing a stamped self-addressed envelope and stating the name and closing date of the Prize Draw) at the address set out below.
14. Arsenal will use entrants' personal details for the purposes of administering the Prize Draw and awarding the Prize. More information about how Arsenal handles personal data is available at www.arsenal.com/privacy-policy.
15. **OTHER IMPORTANT INFORMATION:** Entries must not be submitted through agents or third parties. No responsibility can be accepted for lost, delayed or incomplete entries, or for electronic entries or winning notifications that are not received or delivered (for any reason including as a consequence of communication or network failures). Any such entries will be deemed void.
16. Arsenal reserves the right to withdraw or amend the Prize Draw or these Terms and Conditions if circumstances outside its reasonable control make this unavoidable.
17. Entries must be strictly in accordance with these Terms and Conditions. Any entry not in strict accordance with these Terms and Conditions will be deemed to be invalid and the Prize will not be awarded in respect of such entry. Arsenal reserves the right to verify the eligibility of any entrant and to exclude any entries which it believes to be invalid or in breach of these Terms and Conditions.
18. Arsenal's decision is final in all matters relating to the Prize Draw (including the Prize) and no correspondence will be entered into.
19. Except in respect of death or personal injury resulting from any negligence of Arsenal, to the maximum extent permitted by law, neither Arsenal nor any of its officers, employees or agents shall be responsible for (whether in tort, contract or otherwise):
 - i. any loss, damage or injury to you and/or any third party or to any property belonging to you or any third party in connection with the Prize Draw and/or the Prize (including the winner's receipt or use of the same), resulting from any cause whatsoever; or
 - i. any loss of profit, loss of use, loss of opportunity or any indirect, economic or consequential losses whatsoever and howsoever caused.
20. **GOVERNING LAW AND JURISDICTION:** Please note that these Terms and Conditions are governed by English law. This means that your entry into the Prize Draw and any dispute or claim arising out of or in connection with it will be governed by English law. You and Arsenal both agree that the courts of England and Wales will have non-exclusive jurisdiction in connection with any such dispute or claim.
21. **SPIRIT OF THE COMPETITION:** If you attempt to compromise the integrity or proper operation of the Prize Draw by cheating or committing fraud in any way, Arsenal reserves the right to render your entry invalid, seek damages from you and ban you from participating in any of their future competitions.
