

TRAVEL CLUB TERMS AND CONDITIONS

1. Benefits

Members of the Travel Club receive the following benefits:

- (A) the right to be a member of the Club's Away Ticket Scheme (separate terms and conditions apply – see the Website for details);
- (B) priority tickets to Away Matches in accordance with the terms and conditions of the Club's Away Ticket Scheme; and
- (C) a preferential price on Club organised travel to Away Matches (subject to availability).

2. Use of Membership Card

- 2.1 The Club is not responsible for any Membership Card which is forgotten, lost, stolen, defaced, damaged or destroyed. If the Membership Card is forgotten, lost, stolen, defaced, damaged or destroyed, a duplicate card may be issued to the original purchaser, at the Club's discretion, upon payment by the original purchaser to the Club of a fee. The Club reserves the right to withdraw this duplicate card facility without notice.
- 2.2 The Membership Card is issued for your sole use and you shall not sell, dispose of, assign, transfer, lend or otherwise deal with the Membership Card or the benefit of it to any other person without the prior written consent of the Club. The reference to selling the Membership Card includes: (a) offering to sell a Membership Card (including, without limitation, via any online auction website); (b) exposing a Membership Card for sale; (c) making a Membership Card available for sale by another; and (d) advertising that a Membership Card is available for purchase.
- 2.3 If a Membership Card is lost, you must immediately notify the Club of the same. The Membership Card remains the property of the Club at all times. The Membership Card may be cancelled in whole or in part by the Club at any time without providing any reason.

3. Travel booked through the Club using your Membership Card

- 3.1 Valid membership details must be provided, when booking travel to Away Matches through the Club, to obtain the preferential price.
- 3.2 The Arsenal Terms and Conditions of Travel will apply to all travel booked through the Club.

4. Termination of Membership

- 4.1 Your Membership of the Travel Club may be suspended, withdrawn and/or cancelled without the payment of any refund, in the event that you:
 - (A) breach any of these Terms and Conditions, or any other agreement you have with the Club;
 - (B) are charged, cautioned or found guilty of any football related offence anywhere in the world, are ejected and/or banned from the Emirates Stadium or any other sports stadium anywhere in the world or; or
 - (C) do anything that brings the name of the Club into disrepute.
- 4.2 In the event of any cancellation and withdrawal in accordance with this paragraph 4, no refund shall be payable to you in respect of any unexpired portion of the Membership. The Club further reserves its right to take any legal and/or disciplinary action against any persons as it sees fit in connection with such matters including a claim for an account of profits made from an unauthorised use of the Membership.
- 4.3 In the event that your Membership is withdrawn or cancelled, the Club reserves the right also to exclude you from any other Membership Scheme and/or to disqualify you from applying for any match ticket or season ticket at its discretion and to notify any Football Authority and/or other football clubs of such exclusion or disqualification (and the reason(s) for such exclusion or disqualification).

- 4.4 We reserve the right to terminate the Travel Club at any time. In such circumstances, no refund shall be payable to you in respect of any unexpired portion of the Membership.

5. Exclusion of Liability

Except as otherwise set out in these Terms and Conditions, and to the fullest extent permitted by applicable law, the Club shall not have any liability to the Member in respect of any loss, damage or liability incurred by the Member in relation to the Travel Club.

6. Miscellaneous Provisions

- 6.1 The Club reserves the right to make changes to any of these Terms and Conditions at any time. Such changes will be notified to you via our website at www.arsenal.com.
- 6.2 The invalidity or partial invalidity of any provision of these Terms and Conditions shall not prejudice or affect the remainder of these Terms and Conditions, which shall continue in full force and effect. If any invalid, unenforceable or illegal provision of these Terms and Conditions would be valid, enforceable and legal if some part of it were deleted, the provision shall apply with the minimum modifications necessary to make it legal, valid and enforceable.
- 6.3 These Terms and Conditions, and any dispute or claim arising out of or in connection with them shall be governed by and construed in accordance with the laws of England and Wales. The parties hereby submit to the exclusive jurisdiction of the Courts of England and Wales in relation to any dispute or claim arising out of or in connection with these Terms and Conditions (including in relation to any non-contractual dispute or claim).

7. Definitions

In these Terms and Conditions, the following words and phrases shall have the following meanings: **“Arsenal Terms and Conditions of Travel”** means the Club’s terms and conditions for individuals travelling to Away Matches from time to time, which can be accessed at <http://www.arsenal.com/ticket-membership-terms> under the file name “Terms and Conditions for travel with the club”.

“Away Match” means a match played by the Club’s first team at a ground other than the Emirates Stadium.

“Club” means The Arsenal Football Club Plc.

“Football Authority” means the Football Association Premier League, the Football Association, the Football Association of Wales, FIFA, UEFA, the Football League and/or any other relevant governing body of association football, and **“Football Authorities”** shall be construed accordingly.

“Member” means a member of the Club’s Travel Club.

“Membership Card” means the membership card provided by the Club to members of the Travel Club.

“Membership Scheme” means each of the membership schemes of the Club available to fans, the terms and conditions of which are available on the Website.

“Travel Club” means the membership scheme run by the Club for access to tickets for the Club’s away games.

“Website” means the Club’s website, currently www.arsenal.com.
